# **Risk Management**

We ask that you help by respecting our Risk Management Guidelines.

- You are required to read and be familiar with the fire evacuation procedure.
- Heavy items are not to be kept on the top bunk.
- There is to be no running inside any accommodation area or corridor.
- Crockery and cutlery are not to be removed from the premises.
- Appropriate footwear must be worn at all times within the property.
- The shower and toilet facilities are wet areas requiring responsible and thoughtful use.
- No person under 18 years of age is to leave the complex without adult supervision or permission.
- No ball games or other recreation activities are permitted in the dormitory.
- Water safety rules must be obeyed on the beach and in the water adult supervision for person under 18 years of age.
- Safety signs around the property are to be read and obeyed.
- The breach of any rules is to be reported to an adult supervisor, teacher, or staff member.

# Local Rules (A to Z)

The following information is provided to help make your stay safe and enjoyable.

### **Alcohol**

Responsible consumption of alcohol is permitted with the consent of the Manager.

#### Attendance List

A list of all attendees is to be provided prior to departure.

### **Bedrooms**

Mattresses are not to be moved from room.

## **Damage**

Please report damaged property and equipment. Groups are responsible for the cost to repair any damage.

# **Departure Duties**

Groups are expected to complete departure duties prior to departure.

### **Environment**

To assist in conserving energy, please minimise the use of water and electricity. Please turn off lights, heaters/air-conditioner when not required and ensure short showers etc.

#### **Fire**

In the event of a fire, under the direction of group leaders, groups are to evacuate to the nearest evacuation assembly point and await further instruction.

# Fire Fighting Equipment

Leaders are to be familiar with emergency procedures as well as the position and use of firefighting equipment. Fire Extinguishers are not to be tampered with in any way as it may impinge upon your safety and will incur a recovery cost for re-inspection and any replacement.

### Fire Pit

Campfires are permitted with the permission of the Manager. Campfires are permitted ONLY in the designated firepit, located behind the Hamilton Cottage, and are not permitted during the Fire Danger Period and on Total Fire Ban Days. If the campfire has been used, please ensure that it has been entirely extinguished by soil and water.

### First Aid

First aid is the responsibility of the group. Please ensure that there will be enough vehicles to onsite to be able to evacuate everyone quickly in the case of an emergency.

### **Furniture**

If furniture is moved, please return it to where it was originally found. Please report any breakages & damage incurred to the manager. Repairs to large, expensive items will need to paid for by the group.

#### Meals

It is your responsibility to provide caterers who are accredited Food Handlers and to observe the guidelines and rules displayed in the kitchen. Shoes must be worn in the dining room and kitchen.

### **Noise**

Noise is to be kept to a minimum after 10:00pm and before 7:00am.

# Respecting Others

Please respect the needs and privacy of neighbours.

### Rubbish

A can and bottle bin provided for recycling. Please place all rubbish in garbage bags (provided) and put in wheelie bins. Any excess rubbish will have to be taken by your group. Please contact Manager if bins require emptying if staying for an extended period.

# Security

Security is the responsibility of the group. Upon departure, please ensure that you lock the complex and leave the keys inside.

# **Smoking**

Thuruna is NO non-prescribed drugs and a NO gambling site. Smoking is not permitted with in any building. Please extinguish your cigarette and dispose of responsibly outside.
